a word from our president


Huxley Historical Society started in November of 2005. We received acknowledgement as a nonprofit and tax exempt corporation starting in March of 2006.

It is the mission of the Huxley Historical Society to engage the community of Huxley in the preservation, education and celebration of our heritage and ancestry. goal is to preserve, for research and education, artifacts, information about Huxley and about the lives of people of Huxley from their pioneer origins to the present day.

Since I was born in 1941 and reared in Huxley from that time, Huxley has always been very important to me. I also was on the Huxley Police Department for 34 years and served as Police Chief from 1978 to 2004.

After I retired from the Police Department, I was elected Mayor, serving 3 terms so far.

Huxley has grown from about 400 in the 40's to 3,200 in 2007 after a special census. We have a lot of housing development along with commercial development including an annexation of 500 acres East and Southeast of Huxley where Monsanto and Van Wall John Deere are located along Interstate 35. Van Wall has about 160 acres



they are planning to develop, commercially, this year.

As you can see, Huxley has really changed over the 125 years since it was established and we need your support to preserve the past and future of the Huxley Historical Society. Your continued commitment will enable us to achieve our goals – for those who come after.

January 14, 2007- Call to order at 6:30 Pm in the public library by President Nord.



- Secretary Kalsem read the past Minutes. Corrections were made then the motion to approve the minutes was made and passed.
- The treasury report was given by Treasurer Scott Petersen. The treasure report given and approved.
- Web Master -No report.
- Collections committee report. The committee has completed The Collections Management Policy. The Society needs to vote to accept this policy and to implement it as stands with changes being made later by the committee if needed. President Nord called for a motion to accept the policy as it is currently. Motion passed.

documents with the buffet. It included pictures from the Fjord restaurant when the buffet was in use, and photo's of the ships condition when it was recovered in 2007 and more photo's documenting the final condition after Mr. Martin's repairs.

- Treasurer Scott Petersen reported on the balance and the report was approved.
